- Active participation in the activities of the group such as group seminars

- Doctorate in theoretical physics, mathematics or comparable
- Proven research record in the area of theoretical particle physics or in related mathematical methods
- Sufficient alignment/compatibility with the main topics of the Emmy Noether group. Areas of interest include (but are not limited to): mathematically rigorous descriptions of quantum field theory, quantum integrable models, applications of functional analysis in quantum theory, quantum inequalities
- Excellent knowledge of written and spoken English
- Good organizational and teamworking skills
